SELECTMEN - 110

A 3% increase in salary for 10 months has been added. Cora Stockbridge questioned the health insurance reimbursement for 2 of the selectmen. Mr. Dunn said one is \$534/month and the other is \$513/month and includes a 10% increase.

REVENUES

Cora Stockbridge asked if there were any changes with the prior handout. She said the ambulance fees are not listed. Mr. Dunn said those funds go to the capital fund.

Cora Stockbridge questioned the payment for the recycle and rubbish trucks. Mr. Dunn explained how it is setup and that the fees would be taken out of the surplus fund balance. It appears the funds are not there, Mr. Dunn will correct.

Mrs. Stockbridge recommended going to the articles and then coming back to this.

Cora Stockbridge asked for an explanation on the police department donations. Mr. Dunn said one is from the power plant that he knows of but he does not have the entire list.

Cora Stockbridge said there are a lot of articles on the capital program and asked if it should be stated. Mr. Dunn said it is not a bad idea but they do not need to be recommended by the selectmen.

Cora Stockbridge said there is about 1.7 million left from the water meter article and asked where the money shows. Mr. Dunn said it is in the surplus funds but does not show in his worksheet, as it is not intended to be a financial statement it is only for budget purposes. Mr. Dunn explained the unreserved fund balance summary for Mrs. Stockbridge.

Read into record.

Mr. Maguire commented this is a mandate by the federal government and asked what the town faces if this article doesn't pass. Mr. Dunn said the mandate is for arsenic but the town is looking to treating the others to get better water. If doesn't pass would have to redesign and go to a special town meeting. He does not have figures to treat just for arsenic.

Aboul Khan asked how the surrounding towns are dealing. Mr. Jeffers said Seabrook is the only municipality left to treat for arsenic. Mr. Khan also asked about the health issue. Mr. Jeffers said there is no history on hand. He said if this

article does not pass we would have an administrative order and then it would go to the attorney general.

Cora Stockbridge said she attended the public hearing and it was very informative. She said she does not understand how it went from 8 million to 12 million. Mr. Jeffers said no one considered the new wells being drilled. This figure includes the new wells and the wells that have been replaced.

Aboul Khan asked if the water would be drinkable. Mr. Jeffers explained what the plant would do and within a couple of years a federal mandate would make us do it anyways.

Cora Stockbridge asked when this contract was ratified. Mr. McCann said it has not been fully ratified but voted on in favor of. He commented this is the middle management and their willingness to work with the selectmen on health insurance costs.

Mr. Dunn said there is a new wage schedule with the average increase of about 5.62%. Changes in longevity, uniform and education pay. There is nothing retroactive for the pay increase in any of the union contracts.

Cora Stockbridge commented the selectmen should ratify the contracts before the budget submission date and it shouldn't matter if the unions vote to ratify. Mr. McCann said it doesn't matter if ratified by either side but the selectmen did recommend.
